NON-COMMERCIAL ONE-TON PICKUP

1. A customer would like to renew their one-ton van and is also requesting non-commercial plates.
Can you process this transaction? Why or why not?

2. A customer wants to purchase a one-ton truck that has a gross vehicle weight of 21,000 pounds. They want to display non-commercial plates.
Can you process this transaction? Why or why not?

LEASED VEHICLES

3. A North Dakota dealer leases a vehicle to a company, whose headquarters are in Grand Forks, with vehicles assigned to staff throughout the region, including Minnesota. The individual who will be driving the vehicle resides in Minnesota and will be keeping the vehicle at home.
What is required to be exempt from Minnesota sales tax?

4. A licensed Minnesota dealer / leasing company leases a vehicle to a Minnesota resident.
What is required to be exempt from Minnesota sales tax?

DEATH TRANSFERS

5. How many signatures are required if there is an 'OR' conjunction on a title?

6. What documents are accepted by DVS as proof of death?

7. Can a will be used for sales tax exemption?

DAILY RENTAL VEHICLES

8. A 2023 daily rental vehicle is registered from January – April 2023. A retail customer purchases the vehicle in June 2023.

When will the new owner's registration end?

REGISTRATION EXEMPTION OR ACTIVE MILITARY PERSONNEL

9. A customer that is currently on active duty and stationed at Fort Snelling, Minnesota, wants to renew the registration on their vehicle.

Does the customer qualify for Military Registration? Why or why not?

SALES TAX

10. An individual purchases a 1970 Harley Davidson motorcycle for \$3,500 and registers it in the collector class.

What sales tax is due?

11. An individual owns a 1967 Chevrolet Camaro that is currently registered in the collector class. The owner wants to add a friend to the title and there is no money being exchanged. The owner claims they are exempt from sales tax because the sales tax was already paid when the vehicle was first purchased.

Is sales tax due? If so, how much?

12. Two individuals jointly own a vehicle and want to remove one owner.

Is there sales tax due? Why or why not?

ODOMETER

13. An individual purchases a vehicle that qualifies for the in-lieu tax of \$10.

Is it automatically exempt from an odometer statement?

14. A company purchased a 2021 Ford F250. The truck was previously registered at 15,000 pounds, but the new owner is registering at 18,000 pounds.

Is an odometer statement required? Why or why not?

15. When Aubrey purchased her vehicle, the seller, Joan, estimated the mileage at 35,000. Aubrey transferred the title without checking the mileage on the vehicle. She is now selling the vehicle, and verifying the odometer, writes 34,876 on the title, and gives the title to Dawson. When Dawson's title arrives, the mileage said 'Not Actual.

What form is needed to correct the record, and what signatures are required?
